Mr. Scott Yen, Casualty Society of Actuaries

Scott Yen is a Fellow of the Casualty Actuarial Society (FCAS 1993) and a Member of the American Academy of Actuaries.

He has over 30 years of professional experience in pricing, loss reserve analysis, claim analysis and portfolio analysis. He started his career with Royal Insurance in New York and was with Balboa Insurance, the National Council on Compensation Insurance and Allianz in the US before relocating to Taiwan in 1995 as Regional Actuary, Asia for Zurich Insurance.

Since 1999, Scott is the Regional Actuary, Personal Lines for Chartis Southeast Asia and moved to Singapore in 2009.

Mr. Yoon Yew Khuen, Bank Negara Malaysia

Yoon Yew Khuen is an Actuary in the Insurance & Takaful Supervision Department of Bank Negara Malaysia, where he supports the supervisory assessment of the financial strength and conduct of insurers and takaful operators.

He has also been involved in the development of various policy initiatives such as RBC and ICAAP, as well the Financial Sector Blueprint. Yoon Yew Khuen is a Fellow of the Institute of Actuaries and Fellow of the Actuarial Society of Malaysia.
